- Parking authorization will not be tracked by the vehicle license plate.

# City of Vancouver Off-Street Hourly Wage Employee Parking Permit Agreement

The City of Vancouver (hereinafter "City") and \_\_\_\_\_ (hereinafter "Participant") enter into the following agreement:

- In consideration of \$30 per month, the City agrees that all holders of the parking permit may park in the Vancouvercenter garage on levels P1 and P2, from 8am until 6pm Monday through Friday.
- The participants payment of \$30 per permit per month is in lieu of regular, per stall parking fees that otherwise apply to the Garage; and the participant understands that parking in the garage is on a first come/first served basis and that the City does not guarantee that a parking space will be available at the time and date a holder of said permit attempts to park in the garage.
- Participant vehicles entitled to the \$30 rate purchase price for a parking permit shall have a valid permit displayed in the vehicle as required at all times the vehicle is parked in the garage during the hours and dates authorized by this agreement.
- This agreement is strictly limited to parking fees for the garage and does not modify or amend any other term or condition of Garage use.
- The City reserves the right to cancel this agreement.
